

To be compliant with Politecnico Open Access Policy

ALWAYS upload the publisher's version

If you **can** deposit it Open Access:

Typology: **Post Print publisher's version**

Access Policy: Visible to everybody / Embargo

License tipology: Public-All rights reserved or Creative Commons

If you **can't** deposit OA the publisher's version or if you are not sure, upload two files in the same item:

Typology: **Post Print publisher's version**

Access Policy: Archive admin only

License tipology: Non public-Private/restricted access

Typology: **Post Print /Author's accepted manuscript**

Access Policy: Visible to everybody / Embargo

License tipology: Public-All rights reserved or Creative Commons

WHEN YOU UPLOAD A PAPER ...

CHOOSE THE TYPE OF THE PAPER

Pre-print/Submitted version

It's the first draft of the article before peer-review or article which will never be published

It's not the article in press, it's not the proofs

Post-print/Author's accepted manuscript

The version of the paper after peer-review without publisher's layout (logo, pages, price...)

Post-print publisher version/Version of record

Paper as published

Abstract

Brief summary of the most important points in a scientific paper

Other attached documents

Indices, tables, graphs, images, preliminary parts of the text (cover, title, index, bibliography) and any other type of document or part of the document that does not fall within the above definitions.

It is possible to enter here any other type of document (slide, posters, databases, software, artifacts, prototypes, cartography ...)

CHECK THE PUBLISHER'S POLICY

See Sherpa Romeo box on the right of the record while uploading an attachment to check if you can make OA your paper and in which version

You can also refer to the Publishers' Policy in the Open Access section on the Libraries website that sums up the policies of the main publishers the Politecnico researchers publish with

If you can't find any information about copyright:

- check if the open access policy is available on the publisher's site

- you can send a request letter to the publisher

CHOOSE THE ACCESS POLICY

According to the publisher's policy, select the access policy:

Visible to everybody: if you can archive your paper open access

Embargo: to delay the visibility of the attachment

The Embargo end date is calculated from the date of the first online publication: the item will remain restricted until the end of the embargo when, automatically, it will be visible on Porto@Iris

Archive admin only: if you can't archive your paper Open Access

CHOOSE THE LICENSE TYPE

Choose the distribution license for the paper:

Public to make it Open Access

- **All rights reserved:** It implies that all rights belong to the author or that they have been assigned to the publisher but his policy allows you to make the article OA

- **Creative Commons (CC):** the author defines the rights he grants the readers to reuse his work according to the "Some rights" reserved model

Non public-Private/restricted access

if you can't deposit your paper Open Access

TRANSFER TO LoginMIUR

By choosing YES the file will be sent to the LoginMIUR. LoginMIUR only accepts PDF files smaller than 10 Mb; divide the larger files into several attachments or indicate «No" as upload choice.

The doctoral theses are not sent to LoginMIUR.

NOTE

It is very important to insert here any useful information concerning the paper, typically if the author holds the copyright on his contribution.
